The incident is formally logged and reported to Enterprise Holdings’ risk management team. In FY2017, employees in Enterprise Holdings’ headquarters and independent regional subsidiaries filed 3,288 indemnity and medical claims, contributing to more than 38,448 lost days for injuries. There were 5 known fatalities. The information isn’t available with a regional breakdown.</p>
